High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area

The work we are doing

To create a safe, controlled crossing we will be installing traffic lights on Jerrys Lane / Flats Lane. Where haul roads cross highways, bridleways and public footpaths, controlled crossings are put in place to ensure public safety.

We are building a haul which will be used by our construction vehicles and will be crossing Jerrys Lane. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site. Haul roads are Balfour Beatty Vinci's preferred logistical transport link, as they reduce the number of vehicle movements interfering with the existing local road network and provide the greatest possible control over works activity.

The traffic lights will be in place from 21 June 2021 until 31 December 2024 for the controlled crossing.

When will we undertake these works

The temporary road closure will be in place from to 21 June 2021 to 25 June 2021 and will 24 hours a day. A diversion will be in place – see map.

Our teams may be on site up to one hour before and one hour after the works to set up and secure the site at the end of each day.

The frontages will have access.

Keep all sites safe and secure.

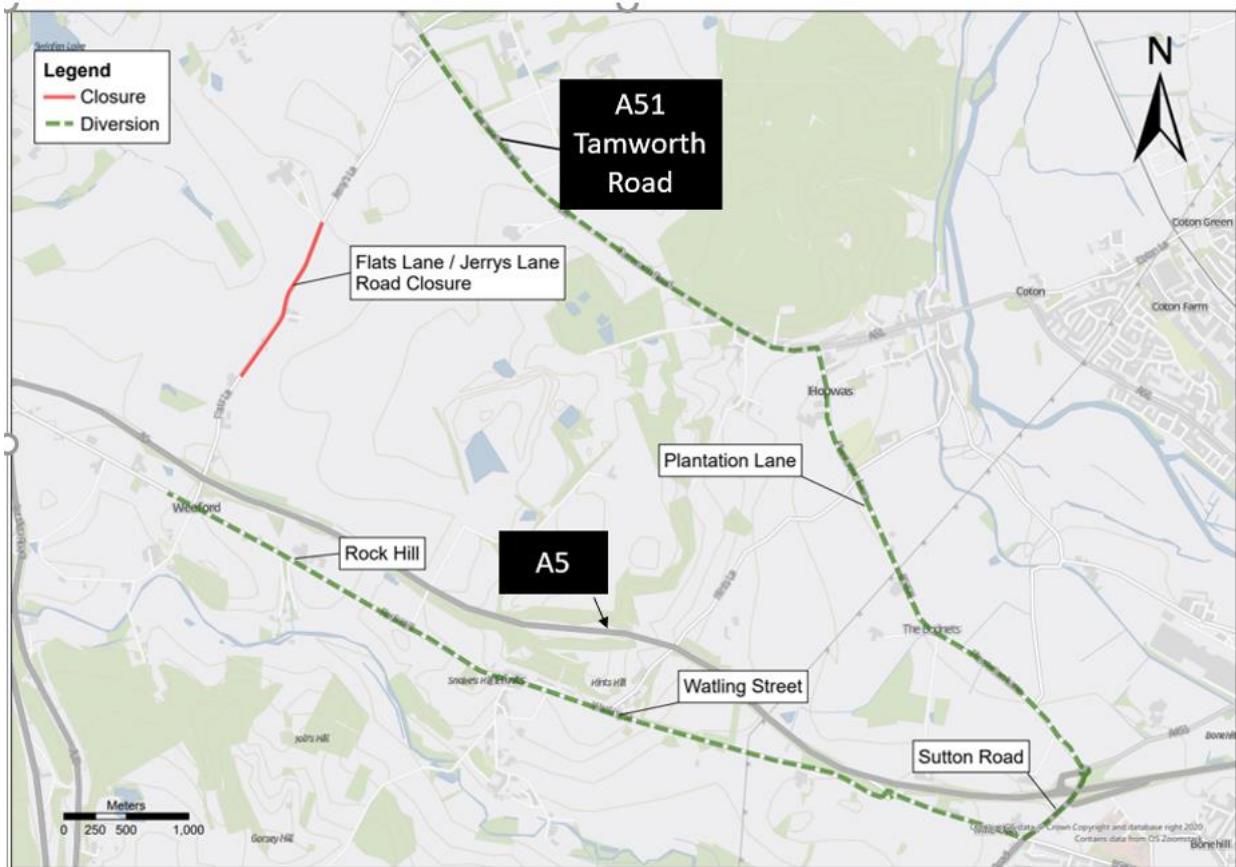
