



# A5, Hints temporary overnight lane closures

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we are doing

We will be carrying out trial trenching, along a section of A5, near Hints, which will involve digging into the ground to establish what is underneath the surface. This will provide us with information on the location of underground utilities, which we need to assess as we develop our construction plans.

We will also be carrying out drainage surveys

For the work to be completed in a safe environment, we will be temporary closing the laybys on this section of the A5

17-18 May - temporary lane closures - eastbound and westbound

19 May - temporary lane closure - eastbound

20-21 May - temporary lane closures – eastbound and westbound for central reservation working

We are working closely with Highways England who will allow us to safely access these areas to undertake these surveys.

## When will we undertake these works

From May 17 until 22 May 2021 for 5 nights

Our working hours will be 8:00pm to 5:30am, overnight and Monday to Friday only

Our workforce can be on site one hour before and after to set up and take our work equipment
