



# Notice of overnight carriageway closures on A5

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

We will be undertaking ground penetrating radar (GPR) surveys along a section of the A5 Hints Bypass. These surveys are non-intrusive and are completed using a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and understand the depth of buried utility services.

## The work we will do

We will have overnight carriageway closures which will take place on the following nights:

- **A5 Eastbound carriageway overnight closures:** Monday 27 June and Tuesday 28 June 2022
- **A5 Westbound carriageway overnight closures:** Wednesday 29 June and Thursday 30 June 2022

The carriageways will be closed overnight from 9pm each evening and reopen at 5am each morning. Our operatives may be on site up to one hour before and after our working hours to set up and secure equipment.

## The diversion route

During the overnight closures, there will be a clearly signed diversion route in place, as shown on the map on page 2.

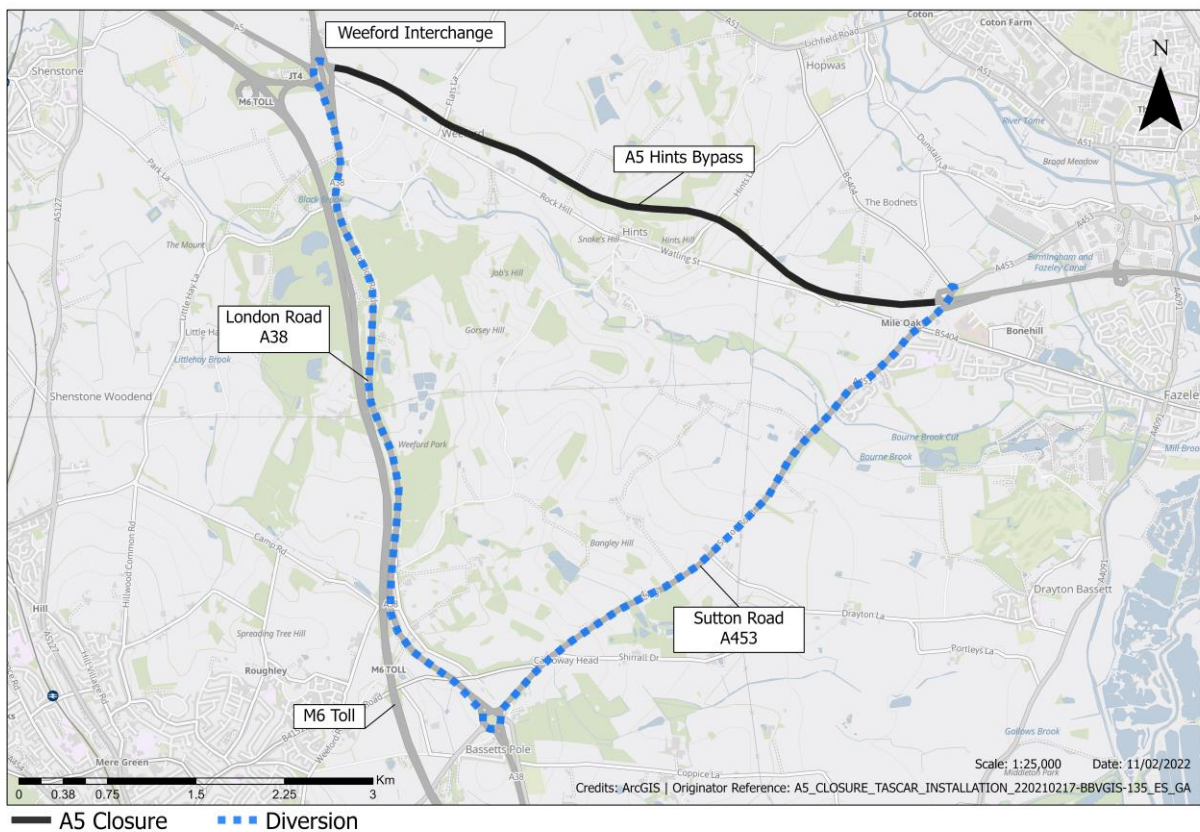

## Map of road closure and diversion route

The map below details the A5 Hints Bypass closure and diversion route that will be in place during the overnight closures.

**A5 Eastbound diversion route:** traffic will be diverted along the A38 London Road to Bassetts Pole roundabout and onto the A453 Sutton Road.

**A5 Westbound diversion route:** traffic will be diverted onto A453 Sutton Road to Bassetts Pole roundabout and onto the A38 London Road.
